



Release and Waiver of Liability

PLEASE READ CAREFULLY BEFORE SIGNING

I, the undersigned _____ of _____
(hereinafter, the "Releasor") assert as follows:

1. **I want to participate in gaming activities held in EGD Facilities** licensed by the Commission, knowing that by doing so, I risk losing money and also risk suffering mental and emotional harm.
2. **I acknowledge that I am presently subject to a Player Self-Exclusion Directive** issued by the Commission on _____ (the "Directive") which prohibits me from participating in all gaming activities held in, and accessing the gaming area of, all Poker Rooms licensed by the Commission.
3. **I acknowledge that I have been presented with, and refused to sign**, a Comprehensive Self-Exclusion Request to prohibit me from participating in all gaming activities held in, and accessing the gaming area of, all EGD Facilities licensed by the Commission (the "EGD Facilities").
4. **I hereby release, waive, discharge, hold harmless and covenant not to sue** the EGD Facilities, the Kahnawà:ke Gaming Commission, the Mohawk Council of Kahnawà:ke, their owners, officers, members, Chiefs, agents or employees (hereinafter, the "Releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including physical, mental and emotional injury, that may be sustained by me, or any of the property belonging to me, whether caused by the negligence of the Releasees (or any of them), or otherwise, as a result of, or in relation to, my participation in gaming activities held in any EGD Facility licensed by the Commission (the "gaming activities").
5. **I assume full personal responsibility for any risks of loss, damage or injury, including physical, mental and emotional injury**, that may be sustained by me as a result of, or in relation to, participating in the gaming activities, whether caused by the negligence of the Releasees (or any of them) or otherwise. I agree to indemnify and hold harmless the Releasees from all claims, demands, causes of action, losses, damages or costs arising from or related to the gaming activities. I hereby forever release, waive and discharge the Releasees (and each of them) from all liability to my heirs, executors, administrators, assignees for all losses, damages and injuries, including physical, mental and emotional injuries, and any claims or demands for such loss, damage or injury.
6. **I am fluent in reading and writing the English language. I have read this Release and Waiver of Liability in its entirety. I understand the nature and effect of this Release and Waiver of Liability. I understand that by signing this Release and Waiver of Liability, I am agreeing that each of the foregoing assertions are accurate and complete and are legally binding on me.**
