- (f) a deposit in the amount of Twenty-Five Thousand (CDN\$25,000.00) Canadian Dollars, which includes:
  - (i) the estimated cost of conducting the Commission's due diligence Fifteen Thousand (CDN\$15,000.00) Canadian Dollars, non-refundable); and
  - (ii) the first annual Operator's Licence fee and the first annual Key Person Permit fees for up to three (3) Key Person Permits Ten Thousand (CDN\$10,000.00) Canadian Dollars, refundable if an application is not granted).
